AUCTION OF TOLL FREE NUMBERS IN THE 833 CODE WINNING BIDDERS ANNOUNCED FOR 833 AUCTION

Final Payments Due January 8, 2020

FCC AU Docket No. 19-101

I. INTRODUCTION

1. On December 17, 2019, Somos completed an auction of certain Toll Free numbers in the 833 area code (833 Auction).¹ The 833 Auction bids raised \$285,075 with 39 winning bidders winning a total of 1,659 Toll Free numbers.²

2. This Public Notice provides detailed information concerning winning bidders, final payments, refunds, default payments, and assignment of Toll Free numbers won in the auction.

II. AUCTION RESULTS

3. The following attachments to this Public Notice summarize the 833 Auction results:

Attachment A: “Results by Toll Free Number” lists each Toll Free number won during the auction, the winning bidder, the winning bid amount, the second-highest bid amount (amount owed for that bid), and if the winning bidder was bidding on behalf of a third party, the name of that third party.

Attachment B: “Results by Bidder” lists for each qualified bidder: the Total Payment, which is the sum of the second-highest bids for numbers won by that bidder; the Upfront Payment Amount; and the Final Payment Amount Due or Refund Due.

4. In addition to the information provided in the attachments, Somos will make available information previously withheld under the limited information procedures for the

833 Auction on January 16, 2020, at auction.somos.com.³ This information includes the Toll Free numbers initially selected by each applicant for the 833 Auction.⁴ Also on January 16, 2020, Somos will release bidding information on every number available in the auction, including, for every bid placed on a number, the amount of the bid and bidder's name.⁵

III. POST-AUCTION PAYMENTS AND REQUIREMENTS

A. Final Payment Deadline and Instructions

5. In the *833 Auction Procedures Public Notice*, the Federal Communications Commission ("FCC" or "Commission") set the deadline for each winning bidder to submit final payment within 10 business days following the release of this Public Notice.⁶ Therefore, the final payment deadline is **January 8, 2020 at 6:00 p.m. Eastern Time (ET)**. A winning bidder may submit a late final payment within five business days after the payment deadline, not later than **January 15, 2020 at 6:00 p.m. ET**, provided it also submits a late fee equal to 5% of the winning bid.⁷

6. All payments must be made in U.S. dollars.

7. Any winning bidder whose Final Payment Amount Due is more than \$300 must pay through a wire transfer to Somos. Any winning bidder whose Final Payment Amount Due is \$300 or less may make payment using an Automated Clearing House (ACH) process. Each applicant is responsible for obtaining confirmation from its financial institution that its payment to Somos was successful.

8. *Wire Transfer Payment Information.* If a winning bidder is providing its payment by wire transfer, it should coordinate with its financial institution well ahead of the due date and allow sufficient time for the transfer to be completed prior to the deadline. **It is extremely important for participants to plan ahead to prepare for unforeseen last-minute difficulties in making payments by wire transfer.** The following information will be needed for wire transfers:

Please ensure that the ACH has a notation that identifies the payer's 833 Auction ID and the payer's name (use exact entity or individual name as used in FCC Form 833).

B. Assignment of Toll Free Numbers Won in the 833 Auction

10. Assignment of Toll Free numbers won during the 833 Auction will occur shortly after the final payment with late fee deadline of January 15, 2020. As with all Toll Free numbers, any Toll Free number won at auction must be managed by a Responsible Organization (called "RespOrg").⁸

11. To aid in the management and identification of Toll Free numbers won at auction, Somos has created a special RespOrg ID for auction numbers in the SMS/800 Toll Free Number Registry for every RespOrg, known as "XSM ID." The XSM ID begins with the RespOrg's two digit Entity ID, followed by XSM. For example, an entity with the RespOrg Entity ID of BR will have an XSM ID of "BRXSM" created for it in the SMS/800 Toll Free Number Registry. The Toll Free numbers won at auction will be transferred from Somos to a RespOrg's XSM ID. All numbers won at auction should remain in a RespOrg's XSM ID, as that will designate the Toll Free number as a number won at auction, which means the number is excepted from the Commission's rules against brokering, hoarding, and warehousing of toll free numbers.

12. All numbers won in the 833 Auction will have a routing record created for them that will permit the numbers to appear as working numbers in the SMS/800 Toll Free Number Registry so as to not be subject to the Commission's rules against warehousing,⁹ as well as the SMS/800 Toll Free Number Registry's Automatic Return to Spare function.

13. The routing will not generate actual calls to the Toll Free number. For the Toll Free number to begin receiving calls, the RespOrg must update the routing record, as it would for any other Toll Free number.

1. Non-RespOrg 833 Auction Winning Bidders

14. Any winning bidder who is not a RespOrg and directly participated in the 833 Auction must contact a RespOrg after the auction to have the newly won number or numbers reserved in the SMS/800 Toll Free Number Registry in accordance with section 52.101 of the Commission's rules.¹⁰

15. A list of RespOrgs can be found on the Somos website at <https://www.somos.com/find-toll-free-number> and click on "Toll-Free Service Providers." All Toll Free Service Providers listed on this site are RespOrgs. RespOrgs that have specifically designated themselves as providing Toll Free Auction Services can be found by clicking the "Toll Free Auction Service" box in the list under the "By Popular Service Offering" heading.

16. Once the winning bidder chooses a RespOrg, that RespOrg (called the "gaining RespOrg") must submit a RespOrg Change (ROC) request, with a future process date of January 15, 2020, and Letter of Authorization (LOA) through the Somos ROC System providing the same information required by all requests made through the ROC System: subscriber name; Toll Free number to be ported; company (if any); and the address, telephone number and email of the person responsible for the number. The LOA must be signed by the winning bidder or its representative. The gaining RespOrg should use the Somos Help Desk ID BR833 for the field normally reserved for the "losing RespOrg."

17. Somos will review each ROC request for completeness. If the LOA is inadequate or other information is missing or incorrect, Somos will reject the ROC request and notify the RespOrg of the reason(s) for rejecting the ROC request. If the LOA and other information is complete, Somos will move the Toll Free number to the gaining RespOrg's XSM ID.

18. ROC requests to Somos under this process will not be subject to the Help Desk RespOrg Change Charge set forth in the Somos Tariff.¹¹

2. RespOrg 833 Auction Winning Bidders

19. For Toll Free numbers won by a RespOrg, the RespOrg will submit a list of its Toll Free numbers through a Special Request on the Somos Portal Website.

20. The RespOrg will log in to the Somos Portal Website and create a new Special Request. The RespOrg can either paste a list of the Toll Free numbers into the Special Request or attach a list of numbers. The request must contain the new auction RespOrg XSM ID.

21. The Help Desk will review the request and compare the list of Toll Free numbers against the winning bidder's list. All matching Toll Free numbers will be moved to the RespOrg's XSM ID. Any Toll Free number(s) not matching the list will be rejected and Somos will contact the RespOrg to explain the reason(s) for rejecting the Toll Free number(s).

22. There will be no charge for moving numbers won in the 833 Auction from the Somos Help Desk to the RespOrg.

3. Post Auction Secondary Market Information

23. Toll Free numbers won in the 833 Auction may be bought and sold on the secondary market; however, the RespOrgs remain responsible for entering and maintaining certain information in the SMS/800 Toll Free Number Registry, including updated ownership and contact information.¹² The FCC directed Somos, through the RespOrgs, to collect contact information of both parties to a secondary market transaction including: (i) name; (ii) address; (iii) email address; and (iv) phone number.¹³

24. RespOrgs must update this information within 60 days of the time the RespOrg has knowledge of the transaction.¹⁴ This obligation falls on the RespOrg of record for the Toll Free number; in the case of a transfer that is accompanied by a change of RespOrg, this obligation applies to the RespOrg providing service to the purchasing subscriber.¹⁵

C. Default Payments

25. If a winning bidder fails to make full payment on its bid(s) or otherwise defaults or is disqualified for any reason, it will be subject to a default payment of 35% of the defaulted bid amount.¹⁶ Specifically, the defaulted bid amount would be the second-highest bid amount, which is the amount that the winning bidder is obligated to pay.

26. If a default involves gross misconduct, misrepresentation, or bad faith by an applicant, the FCC may declare the applicant and its principals ineligible to bid in future auctions and may take any other action that it deems necessary, including forfeiture of its upfront payment and institution of proceedings to revoke any existing FCC authorizations held by the applicant.¹⁷

D. Refund of Excess Payments

27. Somos will return any refunds of upfront payments (minus any final payments and any default payments) by January 30, 2020, (10 business days after the late final payment

deadline).¹⁸ All refunds of upfront payment balances will be returned to the payer of record unless the payer submits written authorization to Somos instructing otherwise.¹⁹ Somos will return each excess payment using the same method by which the payer remitted the funds (ACH or wire).

IV. OTHER IMPORTANT INFORMATION

A. Continuing Prohibition on Certain Communications

28. We remind all 833 Auction applicants that the prohibition on certain communications applies to each applicant that filed an application (FCC Form 833) in the 833 Auction.²⁰ Specifically, each applicant in the 833 Auction is prohibited from cooperating or collaborating with any other applicant with respect to its own, or one another's, or any other competing applicant's bids or bidding strategies. Each applicant will be prohibited from communicating, with any other applicant in any manner, the substance of its own, or one another's, or any other competing applicant's bids or bidding strategies (including with respect to the post-auction market for Toll Free numbers) until after the deadline for final payment with a late fee.²¹ For purposes of the prohibition on certain communications, an "applicant" in the 833 Auction includes: (i) all controlling interests in the entity submitting the auction application; (ii) all holders of partnership and other ownership interests and any stock interest amounting to 10% or more of the entity, or outstanding stock, or outstanding voting stock of the entity submitting the auction application; (iii) all officers and directors of that entity; and (iv) any entity listed as a potential subscriber on whose behalf the entity submitting the auction application will be bidding.²²

29. This prohibition took effect as of the auction application filing deadline, which was **October 18, 2019, at 6:00 p.m. ET**, and ends at the post-auction final payment with late fee deadline for the 833 Auction, which is **January 15, 2020 at 6:00 p.m. ET**.²³ **This prohibition applies to all applicants regardless of whether such applicants became qualified bidders or actually bid in the 833 Auction.**²⁴ For further information on the prohibition, applicants should refer to the *833 Auction Procedures Public Notice*.²⁵

30. *Reporting Obligations.* Each auction applicant that makes or receives a communication that appears to violate the prohibition on certain communications must report

the communication in writing to the Commission and Somos staff immediately, but in no case later than five business days after the communication occurs.²⁶ An applicant must report such a communication even if it does not result in an agreement or understanding regarding bids or bidding strategy that must be reported pursuant to the applicant's obligation to maintain the accuracy of its application.²⁷ Each applicant's obligation to report any such communication continues beyond the five-day period after the communication is made, even if the report is not made within the five-day period.²⁸

31. *Reporting Prohibited Communication.* A party reporting any information or communication that appears to violate the prohibition on certain communications must take care to ensure that any report does not itself violate the prohibition.²⁹ To minimize the risk of inadvertent dissemination of information in such reports, parties reporting a potential prohibited communication must submit a report directly to the following individuals: (1) Margaret W. Wiener, Chief, Auctions Division, Office of Economics and Analytics, FCC, by email to 833auction@fcc.gov; and (2) Joel Bernstein, Vice President, Regulatory and Public Policy, Somos, by email to auctionhelp@somos.com. For the 833 Auction, any such report must be filed according to the instructions set forth in the *833 Auction Procedures Public Notice*.³⁰

32. *Possible Sanctions.* Any applicant found to have violated the prohibition on certain communications may be subject to sanctions.³¹ In addition, we remind each applicant that it is subject to the antitrust laws, which are designed to prevent anti-competitive behavior in the marketplace. If an applicant is found to have violated the antitrust laws or the Commission's rules in connection with its participation in the competitive bidding process, it may be subject to forfeiture of its upfront payment, or full bid amount, and it may be prohibited from participating in future auctions, among other sanctions.³²

B. Limited Information Procedures

33. The limited information procedures for the 833 Auction (sometimes also referred to as anonymous bidding) will remain in effect until **January 16, 2020**, when Somos releases the information previously withheld.³³ Accordingly, communication with other applicants or public disclosure of such non-public information before **January 16, 2020**, may violate the Commission's limited information procedures and the prohibition on certain communications.

Therefore, applicants must take care not to communicate non-public information to the public, financial analysts, or the press.³⁴

B. 833 Auction Toll Free Numbers with No Bids or Defaulted Bids

34. In the *833 Auction Procedures Public Notice*, the FCC stated that it will “defer until after the auction any decision on how to handle any numbers offered in the 833 Auction with no bid or where the winning bidder defaulted.”³⁵ The decision on how to handle these numbers will be made by the FCC.
